

William Marconi Italian Club
Rules and Regulations for All Members and Guests

Rewritten and Modified March 2015

1. **Members shall renew membership annually in order to maintain “member in good standing” status. The Club offers an “Early Bird” renewal period for current members at a reduced rate.**
2. **Members in good standing shall enjoy all privileges and activities provided by membership to the William Marconi Italian Club.**
3. **ALL MEMBERS MUST USE A MEMBERSHIP CARD TO ENTER THE CLUB. Bartenders may require members show a valid membership card prior to be served. Bartender on duty can refuse to serve any member who constantly and consistently fails to use his/her card. A lost card must be replaced for a \$5.00 fee.**
4. **All non-members must be signed in by a member in good standing (a State of NH Law for Private Clubs). A frequent visitor should become a member.**
5. **Members may bring up to 4 non-member guests to the Club at a time. The guests must be signed in by the member. The member is responsible for all actions of the guest(s). Such guest(s) can not remain after the member leaves the Club unless re-signed in by another member.**
6. **Members and guests must enter the Club through the front door AND exit the Club through the front door. Entry and exit through the back yard gate and deck is not permitted. Once patrons have entered through the front door, moving freely within the Club, the deck and enclosed yard area is permitted.**
7. **Private Party Guests (with wall closed) will enter through the Society gate and door. Guests will enter through the Club door at top of the stairs.**
8. **Foul and abusive language is not permitted; any offensive behavior is not permitted; fighting and threatening are not permitted.**
9. **No alcohol and/or alcoholic container is permitted to leave the Club.**

10. **No alcohol may be brought into the Club by a member or guest.**
11. **Members and non-members visiting the Club must be 21 years of age. (Under age guests are permitted at a Private party with the wall closed on a special license.)**
12. **The bartender on duty has the authority to refuse serving any patron who is in violation of Club Rules and is required by NH State Law to refuse to serve any person he/she determines should not consume another alcoholic drink.**
13. **Once a patron has been "shut off" by the bartender on duty, that person is expected to leave the Club. The bartender will ensure the patron will not drive himself/herself or walk home. The bartender will provide cab service if an appropriate driver is not available. If said patron refuses cab service and leaves the Club on own, the member's privileges will be suspended for a minimum of 30 days.**
14. **Disruptive behavior and/or fighting is NOT TOLERATED. The bartender on duty can suspend members' privileges up to 60 days, effective immediately for improper behavior. The Board of Directors will review the incident with the bartender on duty and may increase the suspension. Board of will support bartenders' decisions.**
15. **Any acts of vandalism or destruction of Club property will be the responsibility of the member(s) involved. Restitution will be required and membership suspension can result.**
16. **Footwear and shirts must be worn when on Club premises.**
17. **No drinks and/or bottles shall be placed on the pool table. The pool table may be closed and covered during some Club functions.**
18. **The Club parking areas are considered part of the Club property and are therefore subject to all Club rules, NH State Liquor Laws and the City of Keene Ordinances.**
19. **Private Parties: The club provides an opportunity for members and non-members to use the club facility to hold a private party. All Club rules apply and are in effect during a private party held at the Club. Additional private party requirements are available at the bar or by discussing an event with the Head Steward.**
20. **All Members will follow the smoking policy of the club.**
